**RELEASE FORM**

1. I acknowledge that you are in a position where you receive numerous submissions of ideas, formats, stories suggestions and the like and that many such submissions heretofore or hereafter received by you are similar to or identical to those developed by you or your employees or to those otherwise available to you. Also I acknowledge that you have adopted the policy, with respect to unsolicited submissions of material, of refusal to accept, consider or review such material unless the person submitting such material has signed an agreement in a form substantially the same as this one. Accordingly, I acknowledge that you would refuse to accept, consider or otherwise review my material in absence of my acceptance of each and all provisions of this agreement. I acknowledge that no fiduciary relationship now exists between you and me, and I further acknowledge that no such relationship is established between you and me by reason of this Agreement or by reason of my submission to you of said material.
2. I warrant that I am the sole owner/or author of said material and that I have full right to submit it to you upon the terms and conditions stated herein. I will defend and indemnify

you from and against all claims, expenses, losses or liabilities (including reasonable lawyers fees) that may be asserted against you or incurred by you, at any time, in connection with said material or any use thereof, arising from any breach or alleged breach of these warranties.

3. I have retained a copy of said material, and I release you from any liability for loss or other damage to the copy or copies submitted by me. I understand that your returning the material to me shall not terminate or affect any rights or obligations under this Agreement.
4. Any dispute concerning said material or this Agreement, including, without limitation the validity or effect of this Agreement, or any alleged improper use by you of said material shall be litigated in the courts located in the state of Western Australia, Australia, and both parties consent to the jurisdiction and venue of such courts, and agree not to initiate any action against the other elsewhere. At your sole election, any such dispute may be submitted to arbitration in the state of Western Australia, Australia before a single arbitrator. Said arbitrator shall be well acquainted with the entertainment business in the state of Western Australia, Australia. The arbitrator's decision shall be controlled by the terms and conditions of this Agreement and shall be final and binding. Judgment upon the award of the arbitrator may be enforced in any court of competent jurisdiction. The prevailing party shall be entitled to recover from the losing party, in addition to all other relief to which it may be entitled, its costs and expenses, including, without limitation, actual attorney's fees and the costs of expert witnesses. In the event of any dispute concerning said material or this Agreement, this will be my sole remedy.
5. Any provision or part of any provision which is void or unenforceable shall be deemed omitted, and this Agreement with such provision or part thereof omitted shall remain in full force and effect. This Agreement shall at all times be construed so as to carry out the purposes stated herein.
6. This Agreement may not be changed, modified, terminated or discharged except in writing signed by both you and me. This Agreement, regardless of where executed or performed, shall be governed by, construed and enforced in accordance with the laws of the State of Western Australia applicable to agreements executed and to be wholly performed therein.
7. I hereby state that I have read and understand this Agreement; that no oral representations of any kind have been made to me; that there are no prior or contemporaneous oral agreements in effect between us pertaining to said material; and that this Agreement states our entire understanding.
